### CCBC BEIJING CHAPTER MEMBERSHIP

Corporate	Corporations, partnerships, sole proprietorship or legal entities formed, founded, or incorporated in Canada, which are active in China. If none of the above applies, then the company should have substantial investment or operational interest from Canadian entities or citizens.	¥3000
Associate	Non-Canadian legal entities with demonstrated links or interests in Canada and/or Canadian business	¥3000
Individual	A Canadian citizen or a Canadian permanent resident engaged legally in business in China; a Chinese citizen who is an alumni of a Canadian university with demonstrated business interests in Canada	¥1500
Student	A Canadian citizen or a Canadian permanent resident with a valid student ID from a Canadian or Chinese school and a demonstrated business interest in China; a Chinese citizen with a valid student ID from a Chinese university and a demonstrated business interest in China	¥500

### Voting Rights

Only Corporate and Individual members (Canadian citizens or Permanent Residents) are eligible to vote.

### CCBC Global Membership

CCBC is headquartered in Toronto, Canada and provides services to its members in both Canada and China. For those companies interested in using CCBC's services in both Canada and China, they can do so through a global membership. Companies may apply for a global membership through the CCBC offices in Toronto and Vancouver.
